Old Business

ANJEC: Open Space Grants:

Mr. Szabo will complete the grant application as discussed at the March meeting. The application must be filed by April 19th. Ms. Fobes-Jacoby offered her assistance.

Sustainable Jersey:

Ms. Fobes-Jacoby reported the Green Team met on 4/3/13 and is working on a Green Fair event. Fairview Lake Camp has offered its facilities and the schools will be invited to participate. The EC will have a booth and there will be other information exhibits. Mrs. Emmetts suggested contacting the North RC&D for green fair items. Other suggestions included the exhibit trunk from Soil Conservation; NJDEP, bat and amphibian crossing information. Mrs. Emmetts agreed to work on the Environmental Commission portion of the actions for Sustainable Jersey certification, Dana Mooney, CFO, has joined the Green Team, and the team will participate in Clean Up Day.

Municipal Orchard Update: Ian Blanchard

Mr. Blanchard was not present and this item will be added to the next agenda.

No Littering Signs:

Mr. Branagan reported the following:

The signs will be 18" x 12" and will read as follows:

25 signs @ \$15.58 each = \$389.50

15 posts (8' w/ hardware) @ \$22.74 ea. = \$341.10

Nuts/bolts = \$15.00

Total cost for signs: \$745.00

Silver reflective signs w/ green lettering; locations to be determined; funding through Clean Communities Grant; DPW to install the signs.

The County Administrator indicated the signs could not be posted on existing County sign posts. Mr. Branagan will have Econo Signs fax a quote to Mrs. Wunder to discuss with Ms. Mooney, CFO.

Tree Cutting Ordinance:

The EC discussed exemption of farmland assessed property. Mr. Branagan indicated the Zoning Officer was not in favor of doing so.

Following further discussion, the EC agreed to add farmland assessment as an exemption. Mr. Branagan will discuss the penalty/fine for the tree ordinance amendment with the Zoning Officer.

Water Testing Results:

The stream water test results comparison to prior years was emailed to the EC for their review. Mr. Szabo would provide a copy to Mr. Sadjak for his input. Mr. Sadjak will be a guest speaker at the EC meeting to be held on May 13th.

Anti-Idling Flyer:

Mr. Branagan reviewed the flyer and Sustainable Jersey action requirements, noting the following:

- -An anti-idling resolution must be passed by the Township Committee
- -Signs must be posted at priority anti-idling locations
- -Educational materials must be produced and distributed to the community

Ms. Fobes-Jacoby will contact Warren County for authorization to use their anti-idling flyer with adjustments as needed for Stillwater Township.

Amphibian Crossing Study:

Mr. Branagan reported the following results for the amphibian crossing survey held on Route 619 (entrance to Swartswood State Park):

Spotted Salamanders: 23, 3^, DOR 2 Wood Frogs: 485, 7^, DOR 35 Spring Peepers: 247, 9^, DOR 52 American Toads: 3, DOR 1 Jefferson Salamanders: 48, 26^, DOR 2

Red-Spotted Newts: 8, DOR 1

Fishing Line Receptacles:

The fishing line will be picked up during the first week of each month and brought to the monthly EC meeting from the following sites:

- #1 Entrance to North Shore House on the right side of the road next to the stream.
- #2 Boat House parking lot next to trout tag box on shoreline.
- #4 Veteran's Park, next to trout tag box just before pedestrian bridge.
- #5 Veteran's Park upper parking lot attached to recycling poster.

Mrs. Emmetts:

- #3 Swartswood State Park boat launch just south of 619 park entrance receptacle attached to bulletin board just right of launch area.
- #12 Swartswood Lake, Mill Pond on State Park bulletin board.

Mr. Szabo:

- #6 Private home of Ed Connor located on large pine tree next to fire pit along river.
- Ms. Fobes-Jacoby:
- #7 Saddleback Road just west of the larger bridge on post leading to the river and field.

Mrs. Tracey:

- #11 Hendershot's boat launch attached to post with trout tagging box next to shed.
- Mr. Branagan:
- #8 Route 610 between LC Service and the bridge crossing the river on the right side pullover.
- #9 Just after the bridge across from the Grist Mill at the entrance to the small lost and river.
- #10 Hendershot's boat launch attached to the post with the trout tagging box next to the shed.

New Business

<u>Solar Ordinance Review</u>: A subcommittee was formed by the Planning Board to develop a solar ordinance. Sample ordinances will be distributed by Mr. Branagan to EC members for their review and input.

<u>Lyme Disease Information</u>: Mr. Klimek was contacted by Marty Theys, an advocate for Lyme Disease, who has offered to provide a presentation at a future EC meeting. Mr. Klimek suggested placing a sign at Veteran's Memorial Park depicting a tick and including information.

Route 521 – (2) 55 gallon drums (across from the Boathouse Restaurant):

A memo was provided by Mike Metzger, Sussex County Public Works regarding the drums, which he reported to the Department of Environmental Health Services. The matter will be referred to the Zoning Officer for inspection and follow-up.

<u>Resignation:</u> Ms. Ramberg informed the EC that she will be submitting her resignation in the near future as she is moving. The EC thanked her for her service.

- -Ms. Chammings discussed the proposal of having the Land Conservancy review or possibly update the ERI. The Land Conservancy information will be emailed to the EC for their review.
