# TOWNSHIP OF STILLWATER TOWNSHIP COMMITTEE JANUARY 6, 2015 RE-ORGANIZATION MEETING

The meeting was called to order at 6 p.m. by Municipal Clerk Lynda Knott. Ms. Knott stated that adequate notice of this meeting has been provided according to the Open Public Meetings Act, Assembly Bill 1030. Notice was sent to the New Jersey Herald on January 9, 2014 and was placed on the Official Bulletin Board at the Municipal Building.

Ms. Knott led the public in the salute to the American Flag.

Ms. Knott invited Pastor Timothy Florence of Stillwater Presbyterian Church to provide an invocation.

Jeffrey M. Parrott, Sussex County Clerk, was present to read the Statement of Determination and announced that at the last general election, Ms. Lisa Chammings was duly elected to the Township Committee for a three-year term. Mr. Parrott administered the Oath of Office to Ms. Chammings, congratulating her and wishing her well.

Roll Call indicated the following members present: Ms. Chammings, Mr. Fisher, Mr. Gross, Mrs. Straway, Mr. Scott, and Attorney Angelo Bolcato.

## **Election of Mayor/Chairperson:**

Ms. Knott called for nominations for Mayor. Mr. Fisher nominated Mr. Scott, seconded by Mr. Gross. Ms. Chammings nominated Mrs. Straway, seconded by Mrs. Straway. There were no other nominations so nominations were closed. Ms. Chammings thanked Mr. Scott for his years of service but expressed her opinion that while Mr. Scott has served well during his many terms being Mayor she feels that Mrs. Straway could be a needed change of view. Mr. Fisher voiced his concerns regarding change and gave his support to Mr. Scott. Mrs. Straway expressed her reasons why she feels she is a good candidate for mayor. Mr. Gross noted the position of mayor is difficult and how important it is that the mayor be available during the hours Town Hall is open. A motion by Ms. Chammings was made by, seconded by Mrs. Straway to close discussion. Roll Call Vote for Mr. Scott's nomination as Mayor: Ms. Chammings, no, Mr. Fisher, yes, Mr. Gross, yes, Mrs. Straway, no, Mayor Scott, yes

Mr. Scott accepted the position of Mayor of Stillwater Township for 2014.

The meeting was turned over to Mayor Scott. Mayor Scott noted the importance of elected officials attending the League of Municipalities Elected Official Course

### **Election of Deputy Mayor:**

A motion was made by Mrs. Straway to nominate Ms. Chammings as Deputy Mayor. Ms. Chammings respectively declined. A motion was made by Mayor Scott to nominate Mr. Fisher as Deputy Mayor, seconded by Mr. Fisher. A motion was made by Ms. Chammings to nominate Mrs. Straway as Deputy Mayor. Mrs. Straway respectfully declined. A motion by Mrs. Straway, seconded by Ms. Chammings to nominate Ms. Chammings as Deputy Mayor. Mayor Scott made a motion to close nominations seconded by Anita Straway and unanimously accepted by the Township Committee. Roll Call Vote for Mr. Fisher: Ms. Chammings, no, Mr. Fisher, yes, Mr. Gross, no, Mrs. Straway, no, Mayor Scott, yes – the motion was defeated. Roll Call Vote for Ms. Chammings: Ms. Chammings, yes, Mr. Fisher, no, Mr. Gross, no, Mrs. Straway, yes, Mayor Scott, no – the motion was defeated.

Mayor Scott re-opened nominations for deputy mayor.

A **motion** was made by Mayor Scott to nominate Mr. Gross for Deputy Mayor, seconded by Mr. Gross. Mayor Scott made a **motion** to close nominations, seconded by Mrs. Straway. **Roll Call Vote for Mr. Gross**: Ms. Chammings, no, Mr. Fisher, no, Mr. Gross, yes, Mrs. Straway, no, Mayor Scott, yes – the motion was defeated.

Ms. Chammings stated her reasoning behind her no vote. Ms. Chammings said she nominated Mrs. Straway for Mayor and she was not selected and Ms. Chammings feels Mrs. Straway should be Deputy Mayor because she has served well for five years on the Township Committee and this may be her last year too. Ms. Chammings continued by saying she respected Mr. Fisher and complimented him on his past service as Deputy Mayor but nominated Mrs. Straway because she sees it as a move forward in a different direction.

A **motion** was made by Ms. Chammings to nominate Mrs. Straway for Deputy Mayor, seconded by Mr. Gross. Mrs. Straway once again respectfully declined the nomination. Ms. Chammings asked Mr. Gross as the swing vote who he felt was the strongest candidate for Deputy Mayor. Mr. Gross stated he nominated Mrs. Straway for her experience and her availability.

A **motion** was made by Mr. Fisher to nominate himself as Deputy Mayor, seconded by Mayor Scott. A **motion** was made by Ms. Chammings to nominate herself as Deputy Mayor, seconded by Mrs. Straway.

Mrs. Fisher voiced her concerns and frustrations from the audience.

<u>Roll Call Vote for Mr. Fisher</u>: Ms. Chammings, no, Mr. Fisher, yes, Mr. Gross, yes, Mrs. Straway, no, Mayor Scott, yes – the motion was successful and Mr. Fisher accepted as Deputy Mayor for Stillwater Township for 2015.
