Open Public Session:

At this point, this portion of the meeting was opened to the public. There being no members of the public wishing to speak, this portion of the meeting was closed.

COMMITTEE REPORTS:

Mr. Fisher: Six-hundred and fifty-five pounds of garbage was collected at Clean-Up Day, 679 co-mingles, and eight tires as of Saturday. Stillwater Day will be held on June 20th. A possible Recreation Commission workshop will be held on May 18th. Ms. Chammings brought forward a proposal for a pavilion and paving stones at Veteran Memorial Park. Mr. Fisher spoke with the Township Engineer regarding the upper property at VMP and having it surveyed so as to review the possibility of utilizing it.

Ms. Chammings: Ms. Chammings reported she was approached by two boy scouts and a representative of a corporation proposing the construction of a pathway connecting the parking lot to the bridge and the bridge to the existing walkway, reintroducing Brian Philhower's eagle scout garden in his memory. She presented a rough sketch to the Committee. Mrs. Straway noted several of the actions for the proposal would fall under the point categories toward Sustainable Jersey certification. Many others both individuals and corporations have expressed interest in helping and donating towards the project. Mrs. Straway felt with open space trust funding and outside donations, this project could be a candidate for one of the larger grants through Sustainable Jersey.

The Planning Board met on April 15th and approved the application for a 14,000 square foot pole barn for agricultural storage with conditions applying. Mrs. Straway expressed concern with the size of the structure. One of the conditions of the approval required a future plan for the farm approved by the Rutgers

Cooperative Extension. The Board is currently working on a new ordinance for a simple lot line adjustment and a land use ordinance is on the agenda for introduction at the next meeting.

Environmental Commission met and provided a report on the amphibian crossings. The EC would like to refurbish the old shed from the Recycling Center to be used for recyclable disposal at Veteran's Memorial Park. The shed has been moved to a vehicle and it needs to be determined if the floor can be repaired for placement at the park.

<u>Mr. Gross</u>: Mr. Gross reviewed the report submitted by the Stillwater Fire Department 3/21/15 through 5/5/15. He commended them on their efforts at a recent fire.

The 11th Memorial Day Service will be held on Monday, May 25th beginning at 10 a.m. at the Presbyterian Church and immediately following proceed to Veteran's Memorial Park for a wreath placing. He invited all to attend to honor our veterans.

Mr. Gross and Mayor Scott attended the three-day New Jersey Conference of Mayors in Atlantic City. There was a wealth of information and networking with other mayors from throughout New Jersey.

<u>Mrs. Straway:</u> The Old Tannery Road bridge has reopened. Debris under the Crandon bridge has been removed. A drug trend update and other programs have been held through the Municipal Alliance. Sussex County Day was held on May 3rd, with Mrs. Straway, Ms. Fobes-Jacoby and Ms. Tighe manning the Stillwater booth focusing on grant initiatives. The Stillwater Fire Department participated in the tug-o-war contest.

<u>Mayor Scott</u>: The DPW is currently filling in potholes and cleaning up grit debris from the winter. He cautioned all to be aware of increased bicycle and motorcycle traffic throughout the township due to the warm weather.

<u>Capital Budget Spending Plan:</u> The Committee reviewed the capital budget spending plan to determine the priority items for bonding to be prepared: roads – paving/resurfacing; Phase II municipal building renovations – building, parking lot, oil tank replacement. PSE&G and reserve funding is available. The Committee agreed to review the plan further at the next meeting with the CFO present to clarify any questions.

Dog Census: Ms. Chammings made a **motion** authorizing a dog census to be conducted at a cost of \$8,000, seconded by Mr. Gross. Funding is available through the dog trust fund. **Roll Call Vote**: Ms. Chammings, yes, Mr. Fisher, yes, Mr. Gross, yes, Mrs. Straway, yes, Mayor Scott, yes

Open Space Trust Fund:

Mr. Stein provided a background on the open space trust fund, explaining it has a sunset provision that will expire in 2016 and it would need to be placed on the ballot for the November general election if the Committee wishes for the trust fund to continue next year. The wording must be submitted to the County by August 14th. The Committee discussed the original referendum wording (development, acquisition, and maintenance) and different options for the use of the funding. Ms. Chammings suggested the Committee review the original ordinance and vote on it at the next meeting. She felt the wording needed to be clarified so the residents understand what they are voting on.
