Mrs. Delaney made a motion to reimburse Mrs. Gardner for 3 \$25.00 (\$75.00 total) for Holiday Second by Mrs. Tosti

Tree Lighting- Board- Dec 2 Huge turnout. Costco and Shop RIte expenses \$169. 22 \$47.68 total spent \$216.90 budget \$350. Mrs. Delaney sends thanks to Santa and the Fire Dept. Mrs. Tosti thanked all those behind the scenes.

Field and Pavilion Use Applications/Approvals/Scheduling- Mrs. Tosti- Mr. Sylvester recommended getting in contact with Leagues now that use fields to attend February meeting to review applications earlier for spring season to go over fields requested for use, equipment usage and inventory. Mrs. Tsadilas asked if no representation at the meeting do they get information regarding what is expected from them for maintenance, usage etc.? Mrs. Delaney stated something can be made to attach to application.

Field Maintenance- Mr. Sylvester and Mr. Reilly – Mrs. Delaney stated the bench that was damaged is not repairable and is next to the POD. 4sm 4lg soccer goals and 4 benches

One bench that was broken and deemed unrepairable is owned by unknown. Possibly Travel or Rec soccer. Mr. Sylvester stated during inventory check 3 benches were on the field and a fourth bench was found off the field in the woods is repairable. It was left by the fence for Mr. Raff to inspect. The bench (owned by Stillwater Rec) is repairable. Red paint is marked on all Stillwater Rec Equipment at all fields. Clay having trouble being delivered. Mr. Raff is to have loosely spread. Mr. Raff will have delivered when the field is able to take the weight of the truck without doing damage. Price increased to \$75/ton motion not to exceed \$3,000 will still be able to cover clay requested. Equipment was marked with red paint or ST. (see Mr. Sylvester's inventory list attached). Equipment marked "Other Equipment" owner is unknown. Leagues were contacted to remove all equipment from fields for overseeding and aeration. The Commission will contact Mr. Ragazzo and Mr. Fernandez about removing equipment from Volunteer Field.

Equipment wish list 2023, but use any funds remaining Mr. Raff requested getting the equipment stated in the motion as soon as possible.

Mr. Sylvester made a motion to Purchase from BSN Diamond digger combo \$864 and 5 set of soft base ground mounts (set of 3 \$119)\$600.00 Totaling \$1464 Out of this years budget if available or immediately with next years budget. Second by Mrs. Tosti funds permitted.A vote was taken and all are in favor. Mrs. Tsadilas voted in place of Mr. Reilly and Ms. Falotico voted in place of Mr. Carovillano.

Mrs. Minervino stated some feedback was to Watch a war movie, listen to speakers and were very open to getting together more frequently. Old Business

Grant Purchase List - Mr. Sylvester/Mrs. Tosti — Remaining balance on grant is \$19,070.74. Mr. Sylvester requested an updated quote from the fencing company. Mrs. Tosti has reached out original quote was \$17,500 and is now \$18,800 honoring original quote adding a little to repair of backstop. Mrs. Tosti reached out for an updated estimate to replace instead of repair backstop fencing. Mr. Sylvester will get a price of 475 ft of yellow topper. Decisions must be made by Dec 31 for prices to be held. A tentative workshop meeting may be held Monday Dec 19 to vote on the Grant purchase.

Equipment Wish List 2023: Combo Drag, Soft ground mounts, Pickleball Court at Veterans with needed net/equipment once parking lot is paved. (New Grant available and to be discussed for 2023)

Veteran's, Stillwater & Volunteer Parks: (see field maintenance and attached) Quotes for paving the parking lots from Mr. Raff with remaining use of the 2018 Ordinance funds. Mr. Sylvester and Mr. Carovillano performed an Inventory checklist on November 14.

New Business

Mailing Insert for July 2023 Tax Bills: Event List from Recreation Commission for Annual events will be submitted to the new Tax Collector Terry Beshada. Mrs. Tsadilas asked when a meeting to make the dates will take place. Mrs. Delaney stated mailing does not go out until July and it will be somewhat generic just mentioning events that happen and approximate dates.

New Grant Program for 2023- January 20, 2023 Submission Deadline 5pm- Mrs. Delaney read over what the Grant covers. Mrs. Rumsey stated the Community Center upgrades will be a big part of the grant request and Rec can add wish list for fields for the Grant. Mrs. Tsadilas has previous experience writing Grants. Mr. Sylvester stated it will take a lot of work and will need to have answers as will it fall within Stillwater Regulations, Professionals doing work. Does the Township Committee support it, does the Rec Commission want to do it. Keep Environmental Commission in mind as far as what they will agree with (trails etc. for handicap accessible) Speak with the Town Engineer about what can be utilized that is safe and can be used at Veterans for example.

Equipment Wish List 2023- Digger Combo and base mounts as listed in motion under Field Maintenance above.

Budget 2023- Mrs. Delaney stated will know by April if approved.

Capital Plan for Paving- Mr. Sylvester sent out a diagram to separate and organize. (see details of Mr. Sylvesters request attached along with Mr. Raff's report)

Mr. Sylvester made a motion to approve the Capitol Budget Plan for 2023 as previously discussed and attached detailed diagram provided by Mr. Sylvester (Capitol Plan of 2022 not completed due to increases). Second by Mrs. Richardson. A vote was taken and all are in favor. Mrs. Tsadilas voted in place of Mr. Reilly and Ms. Falotico voted in place of Mr. Carovillano.

Mr. Sylvester made a motion to approve the Parking Lot Improvements (Paving and Striping) as part of Capitol Budget Plan for 2023 as previously discussed and attached Quote as provided by Mr. Raff. Second by Mrs. Delaney. A vote was taken and all are in favor. Mrs. Tsadilas voted in place of Mr. Reilly and Ms. Falotico voted in place of Mr. Carovillano.
