ORDINANCE INTRODUCTION AND FIRST READING

ORDINANCE 2024-01

CALENDAR YEAR 2024 ORDINANCE OF THE TOWNSHIP OF STILLWATER, COUNTY OF SUSSEX, NJ TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Stillwater in the County of Sussex finds it advisable and necessary to increase its CY 2024 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 1.0% increase in the budget for said year, amounting to \$27,089.29 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Stillwater, in the County of Sussex, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2024 budget year, the final appropriations of the Township of Stillwater shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$94,812.52, and that the CY 2024 municipal budget for the Township of Stillwater be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Ingles to forward last years grant to the Township Committee so they can see what they added and asked for.

DISCUSSION ITEMS:

Community Center Fees

Committeewoman D. Delaney stated that the new Community Center Application is virtually ready except for a final decision on the deposit amount. She stated that they have one quote from a cleaning company for the cost of an emergency cleaning. Mayor L. Chammings asked Municipal Clerk V. Ingles to contact JanPro, the current cleaning company, to ask what they would charge for an emergency cleaning.

Committeewoman D. Delaney also stated that she could add to the application that users can bring their own device to stream on the TV there such as an amazon fire stick.

The Committee also discussed once the contract is completed and the fees adopted, a notice be sent to the organizations using the Community Center on a regular basis of the changes. It will also be noted that if there is a private party going on that other organizations cannot freely walk in and out to use the restrooms during a private event.

Township Attorney E. Bernstein also asked that Municipal Clerk V. Ingles send him the new community center application to review.

Stormwater Management

Mayor L. Chammings stated that they are working on the Stormwater Management plan, that it was completed and submitted but it was returned with a couple things to correct. Then they can begin the GIS mapping for the stormwater drains. She also noted that the Township Engineer J. Vuich is the Stormwater Management Coordinator. If any information comes to the Municipal Office to forward it onto him.

Personnel Handbook Update

Mayor L. Chammings stated that the personnel handbook needs to be updated, the last time it was done was in April 2021. She asked Municipal Clerk V. Ingles to send the personnel handbook, collective bargaining agreement with the DPW, as well as the addendums to Township Attorney E. Bernstein.

200th Anniversary

Mayor L. Chammings stated that they need to start planning the 200th Anniversary which is in 2025. She stated that the Recreation Commission is starting to do Stillwater Day again instead of doing one event in the fall with the Historical Society. She discussed establishing meetings to plan the anniversary. She mentioned having each of the Township Committee members rotate going to meetings so that they can all contribute toward the planning of the 200th Anniversary and not have to establish a sub-committee.

A MOTION was made by Committeewoman D. Delaney and seconded by Committeeman G. Scott to adopt Resolution 2024-023.

ROLL CALL VOTE: Committeeman D. Manser; yes, Committeewoman D. Delaney; yes, Committeewoman V. Rumsey; yes, Committeeman G. Scott; yes, Mayor L. Chammings; yes. Motion carried with all in favor.

Before going into Public Session, Committeewoman V. Rumsey stated that the previous week was very busy for the Fire Department. She stated that on January 14th during the bad weather, the Fire Department went on 10 calls back to back responding to fire calls, downed trees, downed wires, etc. She just wanted to thank them for all of their hard work and that they have done an outstanding job.

Committeeman D. Manser also stated that the Fire Department has done a great job.

Mayor L. Chammings also thanked the Stillwater Township DPW for all their work and the great job that they've done. She said that they've had very long hours as well over the weekend and late evenings.

<u>PUBLIC SESSION</u> (any subject – 3-minute limit)

Public Session Opened

Township Resident K. Draghi greeted Township Attorney E. Bernstein and asked if he could say a little about himself so that the public could get to know who he is. Mr. Bernstein explained that he started practicing in 1982 in mostly municipal work and has had his office for the past 25 years. They currently service four municipalities and was retained by Stillwater Township about 30 years ago. Over his time, he's been retained by 18 municipalities total. He has also taught on the subject at many different organizations.

Township Resident S. Michelman stated that she wanted to know if Possum Road would be cleared from the snow. She stated that they hadn't come to plow until 4:00 PM that day and haven't come back since then. Committeeman G. Scott stated that he would check with DPW Supervisor G. Leatham on Possum Road.

Township Resident J. Doherty read the following statement:

"THERE IS AN OLD SAYING THAT GOES LIKE THIS: "WE LIVE.IN HOPE AND DIE IN DESPAIR." I HOPE THAT 2024 WILL BRING A CHANGE THAT AMERICA NEEDS, ESPECIALLY AS IT PERTAINS TO THE BORDER CRISIS. SURELY, THE SENSIBLE AND SANE CITIZENS OF THIS LAND WILL RISE UP, BAND TOGETHER, AND BANISH THIS OBSCENITY FROM OUR MIDST. I HOPE AND PRAY THAT A PERSON OF COURAGE AND STRENGTH WILL LEAD THE CHARGE AND TAKE UP THE CHALLENGE TO REVERSE COURSE AND RESTORE AMERICA TO ITS FORMER GLORY. I PRAY A SAVING SIGN WILL APPEAR ON THE HORIZON AND I HOPE IT WILL BE IN THE PERSON OF DONALD J. TRUMP, THUS ASSURING THAT OUR MUCH-NEEDED HOPE WILL NOT DIE IN DESPAIR.
