Mr. Dolittle (a resident) was curious about the status on pickle ball court proposal and potential locations. Mrs. Tosti reiterated the proposal, quote, and location options that were previously discussed at the last meeting. Mr. Sylvester mentioned the previous plan that had been discussed and approved (painting lines over new pavement and portable nets), but realizes the town may pursue a different avenue. He compared the two plans to a Chevy and Cadillac (financially speaking). While the Cadillac is much preferred, the Chevy will get us to where we need to go. He hopes that the initial plan will be approved and executed this year since the more involved proposal will take more time leaving residents in question for longer. Locations were discussed and potential pros/cons of each. Mr. Dolittle said he is seeing more and more activity on the courts and believes residents would be very grateful for the improvements.

The meeting was closed to the public at 7:30 p.m.

Mr. Sylvester will wait until Stillwater Day is advertised – he plans to advertise via the schools, churches, and scouts.

Mr. Sylvester suggested Mrs. Falotico narrow the list down by the next workshop meeting to better plan the timing for each event. If anyone has any other suggestions, please reach out to Mrs. Falotico.

Mrs. Richardson researched different acts/shows that would be a good fit for Stillwater Day entertainment.

Bubble Show – very interactive, music, magic. \$500 for 30 minutes. \$650 for 45 minutes.

Foam Party (may not work with Stillwater Day due to children needing a change of clothes) - \$550 for 60 minutes.

Although this seems expensive, it seems to be the going rate for these types of acts. Mrs. Richardson reached out to four other options, and all were booked for our event date. Mrs. Richardson will reach out to Kittatinny's Marching Band as well as dance group (fire dancers, hip hop, etc.) for other avenues of entertainment.

Bounce houses – Mr. Sylvester

All access will be providing the stage.

Tri County has a 30x65 tent available for \$495. Starwars bounce house \$575. Small bounce house (for smaller children, which will need to be supervised) \$350. Other bounce houses ranged from \$325-\$375. Portable generator on wheels (one will run four bounce houses) \$225. They are also very quiet, which is a bonus. We will need to lock these in asap, so a decision must be made by the next meeting. The rough estimate on cost in this department was \$2,570 (out of our \$5,000 budget). We can ask the DPW and Fire Department about generators.

Sound system – Mrs. Tosti

Rick as his own sound system. He just needs a generator. He would be happy to MC anything we need him to do. Pay scale was discussed. Mrs. Tosti suggested \$300.00. She will research going rates and discuss during our next meeting.

Field Maintenance - Mr. Sylvester/Mr. Carovillano

Mr. Sylvester requested that the DPW purchase and spread clay at Veteran's Field. Forty tons of clay to be ordered and spread on Veteran's and Swartswood fields. It is requested that Veteran's be delivered by 3/25 and Swartswood by June (AFTER Little League ends). Last year the DPW did a rough spread and it was a big help. The clay situation has improved. Veterans still require some care, but Swartswood looks good. Mrs. Delaney verified that this was discussed at the budget meeting on Mr. Sylvester's Capital Plan. It will be getting done. Mr. Sylvester requested that the specific time frames be relayed due to our team schedules and set events. Mr. Sylvester and Mr. Carovillano will walk the fields as soon as possible to verify how much clay is needed – we do not want to over order.

UPDATE:

The fields still need to be walked, but when this is done Mr. Sylvester and Mr. Carovillano will coordinate clay delivery with the liaison and DPW.

Educational Activities:

Bus Trip – Mr. Reilly 2/17/2024

Event was a success – attendees were very happy with the trip.

Discussion took place on possible sporting event bus trips. Mr. Reilly was in contact with the Yankees – they offer two options:

- 1) Group sale They would need the money 45 days in advance. Bus money can be collected up until the week of trip. We would then be responsible for collecting two large sums of money.
- 2) Discount program each attendee can buy their own ticket where they wish to sit. A code is given so they receive the discounted group rate, but we do not collect any money for a sporting event ticket. The committee agreed this is the best option for us being that we non-profit and lack the ability to fund empty seats.

Mr. Reilly noted that moving forward, sporting event pricing can now vary based on which teams are playing. It is something to keep in mind, as it may turn people away or it might require us to better research specific dates popular teams are playing to ensure the bus will be filled. Mr. Reilly will work on more concrete numbers and potential dates for our April meeting.

Veteran's Event – Mrs. Minervino

Mrs. Minervino will submit a form now since Veteran's Day falls on a Monday for 2024. Mrs. Minervino will look to reserve the Community Center on Saturday, November 9, 2024. More details to follow.

Water Safety Fair – Mrs. Tsadilas 5/5/2024 Rain Date – to be determined 1:00-4:30 p.m.

Fairview Lake

Mrs. Tsadilas has been to the location several times and walked the area to familiarize herself with the grounds. There will be three to four different water demonstrations. Rowboats will be available for use – families will be able to utilize them for 20–30-minute time slots. Mrs. Tsadilas has been in contact with vendors and received responses already. Volunteers will be needed. There is a new book out geared towards older children – H20 Tunes. We received 200 copies for free. Boating books are also free. Coloring books and crayons have been ordered. Mr. Sylvester secured 200 Stillwater Safety Shark Stickers. A fishing pole and two life jackets have been donated to be used as prize giveaways. All asks have been sent, but there have been no responses yet. Our copy of liability insurance is needed. Mrs. Tsadilas will have everything, plus a map, for the next meeting.

Spring Movie in the Park - Mrs. Falotico

Date to be determined. A lengthy discussion took place regarding the dates, weather (indoor movie possibility), and future movie possibilities/how they can be funded. The Lorax must be used by July. It was questioned whether we should utilize this movie for Stillwater Day. Our CFO would like us to consider doing is *around* clean-up day since it was paid for by Clean Communities. In this case it would have to be indoors, which is not ideal. The Committee likes the idea of it being outdoors. Tara will speak

to CFO regarding this, and we will discuss further at workshop meeting. Hampton reached out about working together – this will save money since we can share the cost and divide the movies. A member from Hampton Recreation was present at the meeting. A discussion took place on how the collaboration would work. They will be in touch.

Mrs. Tosti received an email from the CFO regarding the need to remove our Facebook page by 3/29. The cost is high to maintain the Facebook pages. Mrs. Tosti is in the process of seeing what we are able to do on our own. We can no longer use the Stillwater Logo, so we need to brainstorm a new Recreation Logo. Mr. Sylvester recommended making sure the page stays positive, since it will be open to the public for commenting. Mrs. Martin said that the admin can change the settings to approve all comments before posting to ensure there is no negativity.

Walkie Talkies – Mrs. Tosti

Mrs. Tosti spoke to our CFO regarding purchasing walkie talkies to assist in communication during our events. There are three different options:

It will benefit so many different events. It will be taken out of the budget line the CFO chooses.

Mr. Sylvester –

Mr. Sylvester wanted to clear up any confusion and misinformation circulating about what we can and cannot do at Veteran's Park. He brought to the meeting an approved plan of development for Veteran's Park. It showed the fields constructed from 2005 and the approval from the state and from the county engineer department. It showed ways the area can be utilized and how it currently stands. The upper parking lot is there, and it has been approved. Re-application can in fact be used. Mr. Sylvester displayed this in the hopes that it will end discussion on where we can and cannot put parking lots. It is to be kept for our records so in case there is any question it can be utilized as a resource.

Miners Baseball Game – Mrs. Martin

The Miners Baseball game is set for 8/17 (Firework night). One hundred seats will be blocked off and a link will be sent with a discounted rate (\$14.00 for Saturday's). If we need additional seats, the block can be extended. We are not responsible for collecting money, but we are giving the community an opportunity to gather together. The flyer will be created asap.

Mrs. Tsadilas –

As of last month, Mrs. Tsadilas became the cert program coordinator. She will be looking to recruit volunteers. If you know of anyone (they do not have to live in Stillwater) please contact Mrs. Tsadilas. Extensive training is taking place currently.

Mrs. Minervino –

Mrs. Minervino wanted to follow up on Mayor Chammings request to review the "Open Space and Recreation Plan" for any changes that need to be made. Mrs. Minervino took the time to review this and printed out the pages that pertained to us. Although it does not look like there need to be any changes made, it is encouraged members look over to verify. Thank you, Mrs. Minervino!
