North Jersey Cricket Academy (100 children) Veteran's Field Weekends April-July

In each playing site there are 11-12 players so 24 total players with the addition of parents/attendees. The games are 5-6 hours in length. Mrs. Tosti mentioned that we would need to speak to the Township Committee for approval since they are a new team requesting field use. To prepare, Mrs. Tosti recommended they fill out an application with proof of insurance attached. In addition, she requested they please include how many of the children are Stillwater residents and their school districts. The Recreation Secretary's email was given to their representative so that an all-appropriate forms could be sent.
