RENEWAL OF PLENARY RETAIL CONSUMPTION LICENSE THAT IS CURRENTLY INACTIVE FOR 2025-2026

WHEREAS, On May 10, 2024, "ABC" issued Administrative Order (AO) 2024-03 granting blanket relief for all eligible inactive license holders; and
