**RESOLUTION 2025-103A**

**RENEWAL OF PLENARY RETAIL CONSUMPTION LICENSE THAT IS  
CURRENTLY INACTIVE FOR 2025-2026**

**WHEREAS,** On May 10, 2024, “ABC” issued Administrative Order (AO) 2024-03 granting blanket relief for all eligible inactive license holders; and

**WHEREAS,** the Township Committee of the Township of Stillwater, County of Sussex and State of New Jersey, pursuant to the authority vested in it by an act of the Legislature, has heretofore by ordinance provided for the sale of alcoholic beverages in the Township of Stillwater; and

**WHEREAS,** the following named Liquor License holder has filed an application for the license renewal and the Municipal Clerk has received the Tax Clearance Certificate for this establishment, and all fees have been paid.
