In addition, the municipality is precluded from issuing a tax certificate to any prospective purchaser who is or may be in any way connected to the prior owner of this site.

Parcels that are assessed under the Farmland Assessment Act of 1964 will be subject to rollback taxes. In the event that the owner of the property is on active duty in the military, the Tax Collector shall be notified immediately. Taxes and interest charges for 2024 are not included and the purchaser will buy such lien subject to the same. At any time, my regular office hours and before the sale, I will accept payment of the amount due on any property with interest and costs due, to the date of payment.
