 - c. The Township of Hampton continues to concur with its decision set forth in its Resolution that it did in a January 6, 2026, a copy of which is attached.
 2. Upon satisfaction of the foregoing conditions, authorization is hereby given to enter a notation on the tax assessment records to Stillwater Township, the official tax map of the Township of Stillwater and other records as deemed appropriate to indicate that the subject property is assessed by Stillwater Township.
