RULES AND REGULATIONS

1. **Tables and Chairs:** ALL ORGANIZATIONS AND VENDORS MUST SUPPLY THEIR OWN TENTS (IF DESIRED), TABLES AND CHAIRS.
2. **Certificates of Insurance:** All organizations and vendors attending the planned function or event are required to be covered in the amount not less than \$1,000,000 per occurrence. Your insurance policy must establish the above listed minimum coverage requirements and show the Township of Stillwater as an additional insured party. The Township Committee may require "special event " insurance coverage if deemed appropriate. A copy of the required general liability and property damage insurance policies must be submitted with this application and prior to the event. Certain exceptions apply, and the attached harmless clause must be signed.
3. **Parking:** Parking is permitted in designated areas ONLY. There is no parking on the grass or on the driveways. Authorized Emergency Vehicles are the ONLY Exceptions. Temporary parking is allowed for vendors set up prior to the event. All vehicles must be moved to the main parking lot by 1:30pm, so please arrive early to give yourself time to unload your vehicle.
4. **Hours:** Set-up time is 10:30am to 1:30, all vendors should be ready to go by 1:30. Stillwater Day will run from 2:00pm until dusk
6. **Advertising:** If you would like to distribute flyers or posters for this event please request download from taratosti@gmail.com or recreation@stillwatertwp.com
7. **Clean - Up:** All organizations / Vendors are required to completely clean up their area before leaving, including any and all trash.
8. **Prohibited Sales:** There are no sales of silly string, stink bombs, poppers/pop rocks, ink or any other type of squirting liquid. The Recreation Commission reserves the right to approve/ disapprove any or all items to be displayed or offered for sale.
9. **ALCOHOLIC BEVERAGES ARE PROHIBITED**
10. **ALL APPLICANTS MUST PROVIDE THEIR OWN INSURANCE or SIGN THE HOLD HARMLESS CLAUSE .**
